#### **Data Collection**

#### **Provided Information**

- We collect data directly from you or those acting on your behalf when you: Apply for our products and services, register on our website, or use our applications.
- Communicate with us via email, letters, or telephone, including recorded calls.
- Subscribe to our newsletters or other communications.
- Participate in surveys.

Additionally, we gather data about individuals associated with our clients, such as company directors or shareholders.

### **Automatically Collected Data**

We collect data on your interactions with our services through:

- Website usage analytics gathered via cookies and similar technologies.
- Queries made through our registration system or social media channels.
- Payment and transaction specifics.

We may also obtain data from third-party sources, including publicly accessible platforms and our partners.

### **Data Processing Purposes and Legal Grounds**

### **Purposes and Legal Bases**

We process your personal data for various purposes:

- Providing digital currency to fiat exchange services and digital wallet services.
- Handling inquiries, offering service-related information, conducting marketing activities, and protecting our legal interests.

Legal bases include fulfilling contractual obligations, adhering to legislative mandates, legitimate interests, and explicit consent.

#### **Retention of Personal Information**

We retain your personal data only as long as necessary for the original purpose, unless legally required to retain it longer. Retention periods include:

- Payment data: 5 years post-transaction.
- Cryptocurrency transaction data: 5 years after you cease being a client.
- Marketing data: 3 years from the last website visit.
- Conversation records: Up to 3 years.
- Correspondence: 5 years post-client relationship termination.

### **Sharing Personal Information**

We may share your data with:

- Service providers essential for our operations.
- Banks for transaction facilitation.
- Public authorities, regulatory bodies, and courts when legally required.

This enables us to deliver our products and services, manage business operations, and comply with applicable laws.



#### **International Data Transfers**

When transferring personal data internationally, we ensure its protection through:

- Using standard contractual clauses approved by the European Commission.
- Implementing binding corporate rules for intra-company data transfers.
- Partnering with entities in countries recognized for adequate data protection standards.

### **Data Security**

We have implemented appropriate physical and technical measures to protect the information we collect. However, no website, internet transmission, computer system, or wireless connection is completely secure.

### **Your Rights**
